On your 2020-21 FAFSA, you indicated that at any time on or after July 1, 2019, you were an unaccompanied youth who was homeless or were self-supporting and at risk of being homeless. Unaccompanied youth- means you are 21 years of age or younger or still enrolled in high school, and not living in the physical custody of your parent or guardian.

Homeless- means lacking a fixed, regular and adequate nighttime residence. You may be homeless if you are living in shelters, parks, motels or cars, or temporarily living with other people because you have nowhere else to go. Also, if you are living in any of these situations and fleeing an abusive parent, you may be considered homeless even if your parent would provide support and a place to live.

Question 56: Is Student an Unaccompanied Homeless Youth as Determined by High School/Homeless Liaison?

(At any time on or after July 1, 2019, did your high school or school district homeless liaison determine that you were an unaccompanied youth who was homeless or were self-supporting and at risk of being homeless?)

• **Acceptable documentation:**

- Signed form or letter from your high school counselor who is familiar with your situation
- Signed form or letter from any recognized McKinney-Vento practitioner

Question 57: Is Student an Unaccompanied Homeless Youth as Determined by HUD?

(At any time on or after July 1, 2019, did the director of a runaway or homeless youth basic center or transitional living program determine that you were an unaccompanied youth who was homeless or were self-supporting and as risk of being homeless?)

• **Acceptable documentation:**

- Signed form or letter from the director or designee of an emergency shelter program funded by the Department of Housing and Urban Development (HUD)

Question 58: Is Student an Unaccompanied Homeless Youth as Determined by Director of Homeless Youth Center?

(At any time on or after July 1, 2019, did the director of a runaway or homeless youth basic center or transitional living program determine that you were an unaccompanied youth who was homeless or were self-supporting and at risk of being homeless?)

• **Acceptable documentation:**

- Signed form or letter from the director or designee of a runaway or homeless youth basic center or transitional living program
